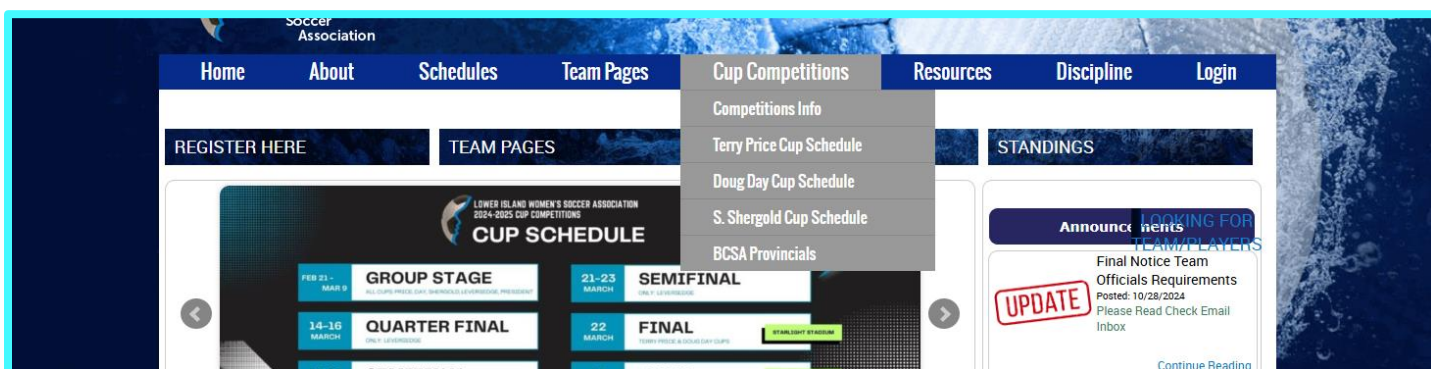
NEW LIWSA cup quarter-final, semi-final and final games shall be decided by penalty kicks if tied after regulation time, in accordance with FIFA Laws of the Game. [LIWSA Rule 9.13]

Match ups are listed as 'Home vs Away', so if your team is listed on the left aka first in the match up, your team is the designated home team.

Home teams are responsible for securing a field. Please contact your field scheduler to request and confirm a day, time and field. Submit to league administrator no later than January 14, 2025. Coaches/Managers please check your email inbox for additional information and timelines.

PLAYER REGISTRATION INFORMATION (Cup Competitions)

Players must be registered or transferred at least seven (7) days before taking part in any cup competition. [LIWSA Rule 9.7] **Please note the transfer deadline as set out by BCSA is January 15.**

BCSA Player Transfer deadline is January 15 – transfer requests must be submitted to LIWSA Registrar (registrar@liwsa.com) a minimum of 3 days prior to deadline and using the appropriate Transfer Form that can be found here:

LIWSA Rule Cup Competition Rules & Regs: 9.14 Playing of Ineligible Players

- a) Any team proven to have played an ineligible player, (i.e. unregistered with team or league, registered in another League outside of British Columbia, disqualified, not eligible for cup play, wrong age, suspended, denied permit), shall be disqualified from further participation in cup competition.
 - i. Any team official proven to knowingly have played an ineligible player will be subject to a fine, forfeiture and further discipline as determined by LIWSA.
 - ii. All of the disqualified team's victories will be reversed in favour of the opposition with a score of 3 – 0

TEAM ROSTERS

GAME DAY ROSTER SHEETS

The following items are **REQUIRED** for each scheduled cup game, and must be printed off from the team page (No handwritten rosters – must downloaded and printed from LIWSA site):

- 1 paper copy of Team Roster for Referee
- 1 paper copy of Team Roster for Opposition
- LIWSA digital ID cards from LIWSA system must be available for showing – **No Exceptions.**
(best practice: download the ID cards at home prior to arriving at designated field – this is in case there is bad cell reception)

Team rosters/game sheets should have the following information:

- Game Schedule Information (bottom of roster page)
- Player First & Last Name
- Team official First & Last Name
- Jersey Numbers – **must** be entered into our system (not handwritten on printed copy)

PLAYER PERMITS (Cup Competitions)

INTRA CLUB PLAYER PERMITS (Adult to Adult)

No Intra-club permits are permitted in cup competition. [LIWSA Rule 9.1]

YOUTH PLAYER PERMIT (Youth to Adult)

A permit shall allow a registered youth player to play for a senior team in a league or local senior Category A/B cup competitions with out affecting her status. [LIWSA Rule 8.1]

- i. A registered youth player on permit with a senior team in a senior category A/B Cup competition is cup tied to that team to the end of that competition.

No Youth players are to be permitted for Shergold, Leversedge and President's Cup [LIWSA Rule 9.5]

TERRY PRICE CUP DRAW & SCHEDULE 2025

*The LIWSA will be represented at the Provincial Cup competition by the Premier Division winner (top seed); followed by the Terry Price Cup winner (second seed); then by the Premier Division second place team (third seed). If one of the top two teams of the regular season wins the Terry Price Cup, then the third placed team from the regular season gets the third seed. If the league winner wins both league and cup, they will have the choice of which seed to take. [\[LIWSA Rule 9.16\]](#)

Teams will be drawn at random, to identify home field designation for each round robin game. There will be 3 round robin games. Please see the draw results below:
